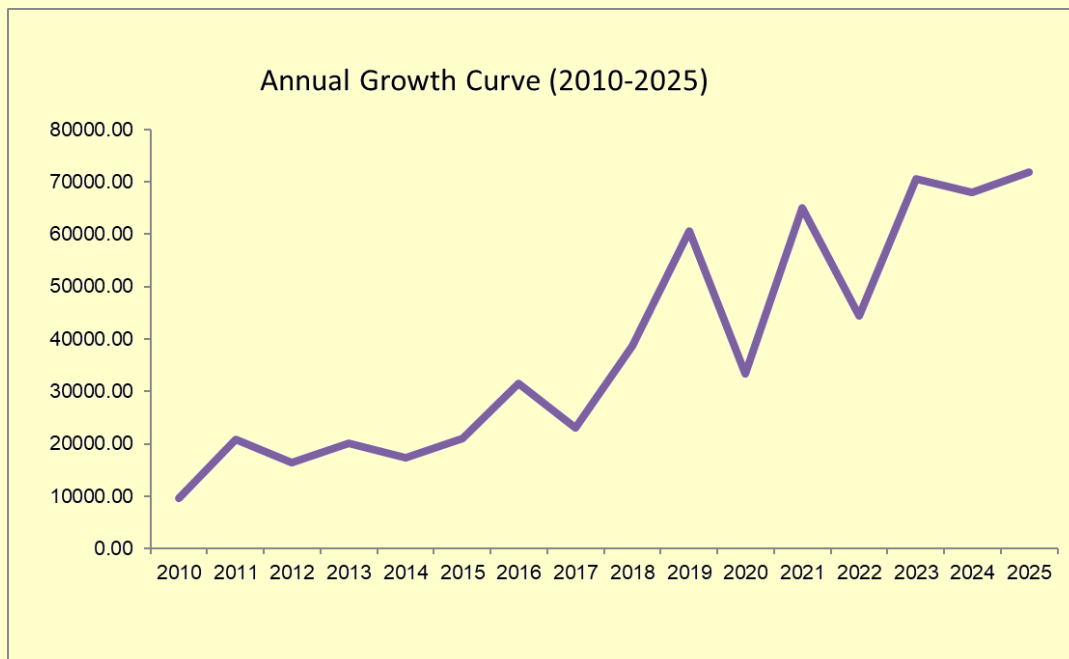

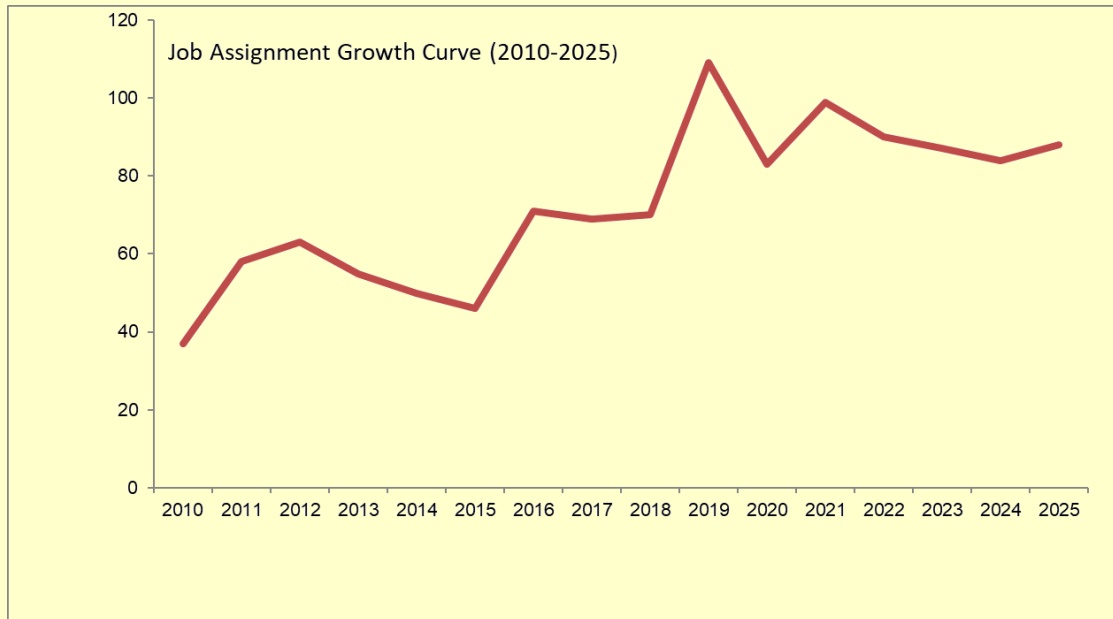


* **real**: means isolating the annual inflation rate of the national currency.

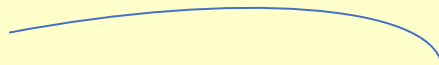
